Admission procedure

(document to be kept by the student)

Academic Requirements

This programme is opened to students (with no age limit) who can certify they have 180 credits plus a Bachelor's degree in Science majoring either in:

- Chemistry
- Biochemistry
- Biology
- Biotechnology
- Physico-Chemistry
- Pharmacy
- Any equivalent diploma accepted by both Universities (University of Versailles Saint-Quentin and Padova)

Students who can certify **180 credits** (ECTS: European Credits Transfer System) **plus** a **Bachelor's degree in Science** will be eligible **both** to the **MBM** master (delivered by the University of Padova) and to the **EFCM** degree (delivered by the University of Versailles).

Students who can certify **180 credits** (ECTS) **without** a **Bachelor's degree in Science** will be eligible to the **EFCM** degree and will be entitled to receive a Professional certificate delivered by the University of Padova.

Applicants must be absolutely fluent in English (TOEFL IBT 85)

School fees

The overall amount of the school fees for the 2-years studies is 20,700 €.

- 200 € non refundable to cover the application
- 11,500 € in June 2018
- 9,000 € in June 2019

The school fees include :

- Specific equipment used during the courses,
- A part of the pedagogical trip and company visits expenses throughout the year,
- Registration fees at the University of Versailles-Saint-Quentin-en-Yvelines and Padova.

A French course is offered as an option. It is organized during the first semester.

Returning application files

To cover the application examination fee, **a payment of 200 €, non refundable, must be done online.**

No application file will be examined before receiving the online payment.

Documents that must be attached to the fully completed application form

These documents are a core part of the application file, to which they must be attached.

Incomplete applications will not be examined.

- detailed content of your current course or diploma supplement
- copies of each degree awarded and the corresponding transcripts in English by a certified translator
- TOEFL certificate indicating the applicant's level of English
- motivation letter on one page
- recent and detailed resume
- reference letter (academic, professional or both)
- copy of passport
- 1 identity photo

Please note that before coming to France, NON E.U. students should contact their Italian Consulates in order to obtain a document called "Dichiarazione di Valore". This document is mandatory to get registered at the University of Padova; it confirms that students degrees are equivalent to Italian degrees.

The full application file must be sent by postal mail AND online platform

Selection

The application file **MUST BE SENT TO ISIPCA**

The file must be completely filled out, **dated and signed**.

The applicant will receive a letter to acknowledge receipt of the application file and the online payment (200 €) by ISIPCA.

The first selection period is set during the first week of March and applicants will receive an eligibility letter by the end of March. **The second selection period** (according to the number of vacancies) will occur during the **first week of June** and the eligibility letter will be sent during the first week of July.

A face-to-face interview or video-conference may be organized to clarify the professional goal description when necessary.

Final admission to EFCM depends on application file, required diplomas, level of English language, motivation, professional experience, precise description of the professional goal, as well as the number of places.

If the applicant is selected, the final admission will be confirmed when ISIPCA receive the official diploma, the transcripts and the payment of the first installment of the school fees (11,500 €).

The first part of the tuition fee (11,500 €) is due **upon reception of the admission letter** (2 weeks after reception of the letter at the latest).

For the second year, the balance of the tuition fees (9,000 €) is due to ISIPCA upon reception of the invoice and before arrival in Padova.

Cancellation and Refund Policy

For any resignation between admission and 15 July, only 90% of the first part of the tuition fees will be refunded. For any resignation between 15 July and the beginning of the course, only 50% of the first part of the tuition fees will be refunded. For any resignation after the beginning of the course, nothing will be refunded.

Health Insurance

E.U. students must provide the European Health Insurance Card.

Non-E.U. students less than 28 years old must pay for the French Student Health Insurance system to be registered at ISIPCA. It amounts to approximately 260 euros (net bank taxes) payable each of the 3 years, plus around 100 euros for complementary cover (around 14 euros for the third party and repatriation insurances for the mandatory internship). This will be paid upon arrival, in registering with Mrs Colette CAZIER - ccazier@isipca.fr

Non-E.U. students over 28 years old must provide their personal health insurance certificate.
